Brother Gallagher discussed the National Conference to be held in Las Vegas, NV at the MGM Grand Hotel & Casino. All hotel reservations for delegates will be handled by the Lodge. The lodge is paying room, tax, and resort fee plus \$600 travel expenses (\$800 travel expenses for any delegates sharing a room). Delegates should plan to arrive on Sunday, August 13th and depart on Friday, August 18th.

Legislative Committee Report – James Gallagher

Brother Gallagher reported that the legislature passed the state pay increase and the bill is headed to the Governor for signature. He also reported that over 2,550 emails were sent via the State Lodge's voter voice system.

"Stay Back Law" was also passed and sent to the Governor for signature. This law would make it a crime to come within 25 feet of a police scene after the officer gives a warning to stay back.

Permit less concealed carry of a firearm over the age of 18 was defeated.

Retired LEOs don't need to requalify annually within the State of Louisiana has also passed and been sent to the Governor for signature. If signed into law, this does not exempt retired members from the annual qualification requirements out of state in HR 218.

Community Engagement Committee Report – Jerry Baldwin

Brother Baldwin reported that the FOP is sponsoring a 5 member team to participate in the Guardian Bowl at Rock n Bowl this Sunday from 1-4 pm.

Social Media Committee Report – Eddie Branch

Brother Branch reported that the updated NOPD handbook would be available via the mobile app this week.

Brother Schlesinger gave an update on the City's vehicle purchases and gave an update on legislation that was passed by the City Council asking Civil Service to evaluate and report back on the possibility of awarding officers who meet the physical fitness standards to receive a bonus annual leave day.
