Brother Gallagher advised the membership of the upcoming National Conference in Nashville, TN to be held on August 27-31. The lodge will provide each delegate with \$500 travel allowance/per diem. The lodge will cover all hotel accommodations and reservations. Members should not plan return flights prior to 2:00 pm in order to have sufficient time to vote.

Retirement Committee – Larry Reech

Brother Reech advised that the employer contribution rate has been set for 2017 to 30.75% and the board voted to lower the target investment ration from 7.5% to 7.33% and to be further reduced over three years to 7.125%. Any excess interest above 7.33% can be used to fund a cost of living raise (COLA). A new executive director has been selected, Mr. Ben Huxen. Mr. Huxen will also serve as the general counsul.

Brother Reech urged all members to attend the pension board meetings, when possible.

State Trustee – Billy Roth

Brother Roth advised that he sent out 10 letters for FOP plate renewals since the last meeting and encouraged all members to check the expiration on their plates.

Legislative Committee – James Gallagher

Brother Gallagher advised that the state lodge's call for sending e-mail messages to the member's respective legislators got over 400 responses for the Probation and Parole bill (HB302). Watch your email for any legislation that the state lodge

is supporting or opposing so that you can send a pre-written email to your legislators. HB 302, which give a raise to Probation and Parole Agents passed the house this evening and will be headed to Senate.

Brother Gallagher also reported that the bill regarding administrative investigations into police officers has been watered down considerably. The final language of the bill reduced the amount of time for an officer to hire an attorney from 30 to 14 days, but only under certain circumstances. The same bill has provisions relative to revoking the POST certification when an officer is terminated from a law enforcement agency and convicted of a felony, domestic violence crime, or excessive use of force that results in serious injury or death. The POST Council can hold a hearing once all appeals are final and vote to revoke an officer's certification

New Business

Brothers John Osburg and Ronnie Brink submitted a written nomination of James R. Danner, Jr. for Honorary Membership in our lodge.

Motion by Pete Menkiewicz for the lodge to donate \$500 to the re-election campaign of Brother Pat Yoes for National Secretary.

Brother Gallagher went over the list of delegates to the National Conference. There will be a delegate's meeting in June at the normal meeting location. Active NOPD officers who are delegates will receive their packets to be detailed to the conference
